Approval of Minutes

Doug Anderson asked for a motion to approve the minutes of the April Board Meeting.

Public Participation

Staff completed State Match verification forms and participated in required Human Resources training. Staff also attended the District Administrators (DA) meeting with all Area 4 supervisors in preparation for upcoming activities and initiatives. The Board Member Tip of the Month focused on the evaluation process, providing guidance and resources to support effective board governance and performance assessment.

NRCS Update

Meghan gave an update on all NRCS activities. The Environmental Quality Incentives Program (EQIP) received 34 applications, with 6 contracts selected for funding. Staff are currently processing payments for completed conservation practices. The Conservation Stewardship Program (CSP) received 10 applications, and 5 contracts were selected. For the Conservation Reserve Program (CRP), all applicants were selected during the first and second sign-up periods. A Quality Assurance Review (QAR) will be conducted June 2–4, 2026. In total, approximately \$700,000 has been obligated for conservation efforts in Greene County through these programs. Amanda asked for any further business or questions, and none were brought forward.

Ag Update

Warren gave an update on construction projects. Staff completed EQIP and CRP conservation practice designs and developed cost estimates for approved projects. A preconstruction meeting was also held for the installation of a livestock watering pumping station associated with a 2023 conservation contract, ensuring project plans and requirements were reviewed prior to construction:

H2Ohio Update

One new contract was approved during the reporting period, and all existing contracts were successfully renewed. Additionally, the deadline for completing contract requirements has been extended, with all contracts now required to be completed by August 31, 2026.

Ditch Maintenance Update

Brandon updated us on the DM programs. The North Fork Massie Creek inspection report was completed and submitted to the Greene County Sanitary Engineering Department. Brandon conducted routine inspections and vegetation spraying activities to support the maintenance and functionality of drainage infrastructure. Letters were mailed to landowners along project areas to notify them of upcoming annual maintenance activities. Brandon completed pesticide applicator continuing education requirements to maintain certification and stay current on best management practices. Amanda asked for any further business or questions, and none were brought forward.

Urban Update

Director Update

Amanda gave the Administrator update. The H2Ohio Cover Crop Project is almost complete; just the final documentation needs to be completed. Overall, H2Ohio programming continues to be very time-consuming. Summer Supervisors School registration needs to be turned in soon. Currently, Amanda, Elise, and Kim plan to go. The combined Greene/Waren leadership float will be June 26th. The Forestry Walk with Pheasants Forever will be held on 6/13. Hopefully, the Tire Collections will return in June, July, Sept., and October. We have received the grant funding from Ohio EPA but have not yet secured the disposal contract. Plans are in motion for the annual meeting and election. We will once again be hosting a joint meeting with Greene County Farm Bureau- Amanda and Brooks will work out the details, hoping for the 1st week in September. The Form 11 was completed and will be submitted following the meeting. Amanda asked for any further business or questions, and none were brought forward.
